A COMMODITY SUPPLEMENTAL FOOD PROGRAM, NOURISH IS NYCP'S LARGEST PROGRAM SERVICE BY THE EXPENSE AND JOINTLY FUNDED BY USDA AND NEW YORK STATE. THE PROGRAM HELPS DISTRIBUTE LARGE NUTRITIOUS FOOD PACKAGES TO LOW-INCOME SENIORS FROM A HOME OFFICE IN THE MOTT HAVEN SECTION OF THE BRONX AND OVER 100 SITES THROUGHOUT NEW YORK CITY AND PART OF WESTCHESTER COUNTY. NOURISH SERVES FIVE DAYS A WEEK, ONE DAY DURING EARLY MORNING EXTENDED HOURS AND ONCE A MONTH ON THE WEEKEND AS NEEDED AT THE HOME SITE. THESE MONTHLY PACKAGES SERVED 15,330 SENIORS (UNDUPLICATED #) AND DISTRIBUTED 3,683,841 MEALS FOR FY21, WITH A COST PER MEAL OF \$1.58.
