SPECIFIC GOALS OF THE ENRICHED PROGRAM WERE TO ENHANCE NUTRITION AND PHYSICAL ACTIVITY THROUGH STANDARDS-BASED GARDENING ACTIVITIES FOR STUDENTS AND STAFF; INCREASE ACCESS TO FRESH FOODS IN THE COMMUNITY; ESTABLISH A NETWORK OF COMMUNITY GARDENERS THAT CAN HELP SUPPORT AND MAINTAIN GARDEN ACTIVITIES AND PRODUCTION; AND CREATE A COHESIVE TIMELINE OF ACTIVITIES THAT MADE HEALTH PROMOTION AND PHYSICAL ACTIVITY A PART OF DAILY ACTIVITIES. BY THE END OF FY16, THERE WERE 10 KEY STAKEHOLDERS COLLABORATING IN WELLNESS COMMITTEE MEETINGS AND SUPPORTING THE INITIATIVES, AND THE SCHOOL ADOPTED 'DIG IN' AS A PART OF THEIR CURRICULUM. IN ADDITION, NYCP CREATED A COMPOSTING PROGRAM AT
